We can deliver our service over the available deployed Private infrastructure means (Fibre To The Home, Fibre to the Basement (VDSL) and Fixed Wireless). Services that contain a monthly usage allowance will have speed restrictions applied to 1024Kbps downstream and 512Kbps upstream when the allocated monthly allowance is reached. No additional charges will be applied to your account. To assist you in managing your usage you can monitor your allowance via our customer portal. Notifications are sent to your selected e-mail address once you have consumed 50%, 85% and 100% of your allocated allowance.

All voice services are delivered as VoIP (Voice over IP) via your active Internet Service.

To Get Active Voice service you must have an Internet service provided by Active Utilities.

during the sign-up phase and able to assist with alternate solutions if required.

You will be provided with a preconfigured NetComm wireless router with your

service. All service and performance metrics are based on use of this device. Any BYO device must be approved for the technology used to connect your premises and have an FXS voice port for your voice service, you hold responsibility to ensure it is operating effectively for the service we provide to you.

Minimum Terms:

Important Conditions:

Our service is provided to you with one (1) Static IP address and one (1) Fixed Landline number. We may share this information with authorized Australian law authorities if requested without your permission.
